After graduation from SNU, Marchant continued his education at the University of Texas School of Law and graduated with a Juris Doctorate.

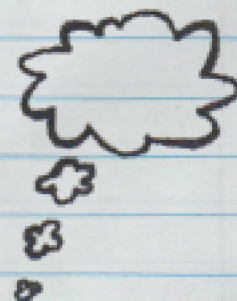
